NEAR EAST UNIVERSITY SUMMER TERM REGULATIONS

SECTION ONE Aim, Scope, Base and Definitions

Aim

ARTICLE 1 - (1) The purpose of this Regulation is to regulate the procedures and principles of education opportunities provided throughout the summer term apart from the fall and spring terms.

Scope

ARTICLE 2 – (1) This Regulation covers the provisionS of education and training given during the summer term at Near East University.

Base

ARTICLE 3 - (1) This Regulation is based on the amended Higher Education Law No. 65/2005 of the TRNC and the Higher Education Law no. 7, 14 and Appendix 26, dated 04.11.1981 and numbered 2547.

Definitions

ARTICLE 4 – (1) In this Regulation references are as follows;

- a) Relevant Committee: Committee of the relevant faculty, institute or vocational school,
- b) Relevant Executive Board: Executive Committee of the relevant faculty, institute or vocational school,
- c) Rector: Rector of Near East University,
- d) Senate: Senate of Near East University,
- e) University: Near East University,
- f) University Executive Board: Executive Board of University.

SECTION TWO Term Education and Regulations for

Aims of Summer Term Education and Regulations for Summer Term Education

Aims of Summer Term Education

ARTICLE 5 – (1) Aims of Summer Term education are as follows;

a) Benefiting from the education and training facilities of university during summer.

b) Opening the compulsory / elective courses and supporting the postgraduate studies as well as employing teaching staff from abroad.

c) Providing students who are enrolled in double major and minor programs with opportunities to follow these programs.

ç) Providing successful students with opportunities to graduate in a shorter time.

d) Providing students with opportunities to take the courses they failed in regular terms.

e) Increasing the quality of education by eliminating the accumulation of students in the departments.

Akademic calendar

MADDE 6 - (1) Opening of courses, enrollment in courses, beginning and ending of courses, exams and other related matters are carried out in the academic year as determined by the Senate.

Opening courses

ARTICLE 7 - (1) The courses that are included in the normal education programs of the university are opened during the required periods and these courses can not be postponed to the summer term.

(2) Courses to be opened during the summer term, student requests, eligibility of the lecturer who will give the lecture are determined by the Executive Board upon the demand of the proposal of the administration of department.

(3) The minimum number of students required for the opening of courses and / or groups during the summer term is at least two in the undergraduate and graduate courses and this is determined by the University Administrative Board. If the number of registered students is below the minimum required number to open a course, a decision of the Executive Board with reason is required to open the course.

(4) There are no restrictions for number of students in the courses related to the thesis in the graduate programs.

Duration

ARTICLE 8 - (1) During the summer semester, courses are implemented as the number of hours scheduled during a normal semester. The duration of the summer term is at least four weeks including the summer term exams.

(2) The summer term is out of the maximum duration of education.

Registration

ARTICLE 9 – (1) Post-graduate, undergraduate and associate degree students can take a maximum of 3 courses with 12 credits in summer term.

(2) Students may also register to courses that they have not taken from previous terms or planned to be opened in the future terms during summer term.

(3) In the summer term, adding, leaving or withdrawal from courses cannot be done.

Evaluation of achievement

ARTICLE 10 - (1) At the end of the Summer Term, students' general grade average is calculated.

(2) The grades taken in Summer Term are shown in transcripts as Summer Term.(3) Students who fulfil the requirements specified in the relevant regulation may graduate at the end of the summer term.

SECTION THREE Other and Final Provisions

ARTICLE 11 – Summer Term is regarded as a separate semester except for fall and spring semesters.

ARTICLE 12- In summer terms, students pay a fee per course they take.

Taking courses from other universities during summer term

ARTICLE 13-1. In order to take courses from other universities during the summer term, the student's grade point average (GPA) must be at least 2.0.

2. It is possible for a student to take up to 2 courses at the other university during a summer term. The total number of courses taken from other universities other than NEU can not be more than 5.

3. A course opened in NEU in the summer term can not be taken at another university.

4. The language of the course to be taken from outside must be the same as that of NEU. 5.The student must give a petition to the head of department in order to take a course from another university at the end of the spring term. In the petition, name and address of the university, and courses intended to be taken must be specified. The petition must be approved by the Executive Board of the Faculty following acknowledgement and approval of it by the Departmental Committee. The deadline to issue a petition to take courses from another university is the day registrations carried out for summer term at NEU.

6. Students taking courses from other universities must submit the transcript to the Student Affairs Office for each course / course that he / she has taken.

7. If the student is unsuccessful from courses taken the grades received will not be transferred to the student's transcript.

8. Students pay tuition fees to NEU for each course taken from other universities.

Cases where there are no provisions in the regulation

ARTICLE 14 - (1) In cases where there is no provision in this Regulation, the provisions of other regulations of the university apply.

Effect

ARTICLE 15 - (1) This Regulation shall enter into force on the date approved by the University Senate.

Executive

ARTICLE 16 - (1) The provisions of this Regulation are executed by the Rector of the Near East University
