## NEAR EAST UNIVERSITY REGULATION FOR APPOINTMENT AND PROMOTION TO ACADEMIC POSITIONS

## Scope

ARTICLE 1 - This Regulation sets out the criteria required for promotion and appointment of academic staff serving at Near East University to academic titles "Assistant Professor", "Associate Professor" and "Professor". This Regulation also covers the terms relating to the use of academic titles obtained in other universities.

## Promotion and Appointment to the Assistant Professor Position

ARTICLE 2 - To be eligible to be considered for promotion to Assistant Professor Position, the applicant is required to have a Ph.D. degree, to have acquired a medical specialist title, or to have acquired competency in one of the art disciplines to be determined by the Senate of Near East University.

ARTICLE 3 - Those, who meet the condition specified in Article 2 of this Regulation, must have completed the training of trainers organized by universities, or successfully completed the GCC/LOD 602 "Training for Learning" course with a grade of B, have a minimum of 1.00 Cumulative Publication Score (CPS) and 1.00 Academic Merit Indicator (AMI) or 100 Academic Merit Points (AMP) for the last year, and have published at least one (1) article in a journal indexed in the WOS or Scopus databases under the name of NEU (those applying to the field of law must have published at least 1 (one) article in a journal indexed in the TR index database.

ARTICLE 4 - Foreign language proficiency is sought in the promotion and appointment of academic staff. To be eligible to be appointed as Assistant Professor, candidates are required to have scored at least 60 points in YDS (Foreign Language Exam) or in a foreign language exam of which equivalency approved by YÖDAK and/or YÖK, to have scored at least C ( $D$ for those in Turkish programs) from the NEU Foreign Language Proficiency Test (NPT) conducted by the NEU Rectorate, and at least 55 ( 50 for those in Turkish programs) from the English Proficiency Test for Teaching (EPTT) conducted by the NEU Rectorate. (The foreign language documents to be submitted must be approved by the Education Unit and should have at least one year of foreign language exemption covering the application date. KPDS, ÜDS, or their equivalents approved by the Higher Education Council have a maximum exemption of up to 5 years according to our university's equivalence table).

ARTICLE 5 - Candidates, who apply for the assistant professor position, undergo a preliminary evaluation by the "NEU Academic Evaluation Commission" regarding their documented scientific studies and other academic activities in terms of quantitative criteria according to the scoring system in Annex 1, and the minimum requirements in Annex 2."

ARTICLE 6 - Candidates applying for the Assistant Professor position, who are deemed suitable by the NEU Academic Evaluation Commission and have shown success in the foreign language
exam, are required to submit their resumes, scientific works, and publications in four copies to the relevant dean's office or school directorate.

ARTICLE 7 - In order to review and evaluate the condition of candidates applying for the Assistant Professor Position, the Dean of the related Faculty, or the director of the respective institute or school affiliated with the Rectorate determines three professors or associate professors, preferably one of whom is the administrator of that unit and one of whom is from outside NEU, engaged in the discipline that the candidate applied for. The dean or the respective director delivers the documents of each candidate to these faculty members and asks for a written opinion. Each faculty member reviews the candidates' documents and submits his/her report to the respective unit within a month starting from the date on which the documents have been delivered to him/her. The dean or director submits their opinions and suggestions to the Rectorate along with the file. NEU Board of Directors takes the decision to appoint the candidate in line with the submitted file and submits it to the NEU Rectorate for approval. The Assistant Professor certificate of the candidate appointed by the Rector is issued by the NEU Rectorate.

## Promotion and Appointment to the Associate Professor Position

ARTICLE 8 - In order to be promoted and appointed to the associate professor position, it is necessary to be successful in the associate professorship exam and meet the requirements specified in Article 9 of this regulation.

ARTICLE 9 - In order to apply for the exam for the associate professor position, it is required:
a) To have acquired the title of assistant professor, and/or doctor, and/or specialist doctor
b) To have scored at least 60 points in YDS (Foreign Language Exam) or in a foreign language exam of which equivalency approved by YÖDAK and/or YÖK, to have scored at least C ( D for those in Turkish programs) from the NEU Foreign Language Proficiency Test (NPT) conducted by the NEU Rectorate, and at least 55 (50 for those in Turkish programs) from the English Proficiency Test for Teaching (EPTT) conducted by the NEU Rectorate. (The foreign language documents to be submitted must be approved by the Education Unit and should have at least one year of foreign language exemption covering the application date. KPDS, ÜDS, or their equivalents approved by the Higher Education Council have a maximum exemption of up to 5 years according to our university's equivalence table. The foreign language documents previously submitted to the Rectorate for appointment to the assistant professor position in accordance with this regulation are also valid for application to this position), having a minimum of 1.25 Cumulative Publication Score (CPS) and 1.25 Academic Merit Indicator (AMI) or 125 Academic Merit Points (AMP) for the last two years (evaluation will be made by taking into account their working periods at our University),
c) The documented scientific studies and other academic activities of candidates applying for this position are required to be deemed appropriate by "NEU Academic Evaluation Commission" in terms of quantitative criteria according to the scoring system in Annex 1, and the minimum requirements in Annex 2.

ARTICLE 10 - After obtaining the title of Ph.D. or medical specialist, or acquiring competency in an art discipline, the applicant is required to have worked at least 3 (three) years as an academic staff in the applicable scientific discipline (at least two years of which must be in full-time status) at a higher education institution, and to have at least 2 articles published under the name of NEU in a journal indexed in the WOS or Scopus databases

ARTICLE 11 - Candidates applying for the associate professor position are required to submit a file consisting of six (6) authenticated copies of their resumes, scientific studies, and publications to NEU Rectorate.

ARTICLE 12 - If the candidate applies for the associate professor position in a department other than the department and/or relevant division, the written opinion of the head of the department to which he/she applies is requested.

ARTICLE 13 - The jury for the associate professorship examination is composed of 5 full members and 2 substitute members, the majority of whom are selected among professors from other universities considering the candidate's expertise and research area in the field of science applied for. NEU Executive Board is the organ to decide who will be appointed as jury members. If an adequate number of members cannot be found in the same field of science, or the nature of the candidate's field of science or expertise and research areas necessitates, jury members may be selected from closely related fields of science.

Before the meeting, the members of the scientific jury prepare their comprehensive reports concerning the originality, conformity, contribution to the field of science, and completeness of the scientific works submitted by the candidate. The scientific jury convenes with the participation of all members, selects a member among them as the chairperson, evaluates the applicants' reports, and delivers either an "affirmative" or a "negative" decision regarding each candidate.

If the jury's decision is "affirmative", the jury invites the candidate to take an oral, or where necessary, a practical and applied examination. Grounding on the works submitted by the candidate, the Jury evaluates the candidate's knowledge accumulation in the applicable discipline through the oral exam and concludes unanimously or by majority of votes whether the candidate is successful or not.

Those, whose scientific works are deemed satisfactory but fail in the oral exam, are allowed to take a second oral exam not earlier than six months. Those, who fail the oral exam for the second time, can't apply again for the associate professor position for at least a year.

The scientific jury verbally notifies the candidate about the decision taken by the jury and delivers a file including the jury's decision, jury members' reports, and a detailed examination report regarding each candidate to the Rectorate. NEU Executive Board takes the decision to appoint the candidate in line with the decision of the science jury regarding the promotion of the candidate and submits it to the NEU Rectorate for approval. The Associate Professorship achievement certificate of the candidate, who is appointed by the Rector, is delivered by the NEU Rectorate.

ARTICLE 14 - Applications for the Associate Professorship position are evaluated and concluded as "affirmative" or "negative" latest within two months. The meeting of the scientific jury and its working conditions are organized by the Rectorate.

## Promotion and Appointment to Professor Position

ARTICLE 15 - The eligibility requirements for promotion and appointment to the Professor title are as follows:
a) After obtaining the title of Associate Professor, the candidate is required to have worked as an academic staff at a higher education institution for a minimum of five (5) years in the applicable field; three (3) years of which must be in full-time status, and to have minimum three articles published under the name of NEU in journals scanned in WOS or Scopus databases,
b) The scientific studies and other academic activities of the candidates are required to be deemed appropriate by the Academic Evaluation Commission in terms of quantitative criteria according to the scoring system in Annex 1, and the minimum requirements in Annex 2,
c) Having produced original works in his/her own field and/or having practical-oriented studies in branches with applicable fields,
d) To have scored at least 60 points in YDS (Foreign Language Exam) or in a foreign language exam of which equivalency approved by YÖDAK and/or YÖK, to have scored at least C ( D for those in Turkish programs) from the NEU Foreign Language Proficiency Test (NPT) conducted by the NEU Rectorate, and at least 55 (50 for those in Turkish programs) from the English Proficiency Test for Teaching (EPTT) conducted by the NEU Rectorate. (The foreign language documents to be submitted must be approved by the Education Unit and should have at least one year of foreign language exemption covering the application date. KPDS, ÜDS, or their equivalents approved by the Higher Education Council have a maximum exemption of up to 5 years according to our university's equivalence table. The foreign language documents previously submitted to the Rectorate for appointment to the assistant professor position or associate professor position in accordance with this regulation are also valid for application to this position),
e) Having a minimum of 1.25 Cumulative Publication Score (CPS), and 1.25 Academic Merit Indicator (AMI) or 125 Academic Merit Points (AMP) for the last three years (evaluation will be made by taking into account their working periods at our University).

ARTICLE 16 - Candidates applying for promotion to Professor Position are required to submit six authenticated copies of a file to the NEU Rectorate. This file is required to cover and document their resumes, scientific studies, congress, and conference papers presented, publications, list of citations to these papers, and publications, the artworks, performances and relevant documents, education and training activities, PhD studies, artistic competence or master's degree (scientific expertise) studies ongoing or finalized under their supervision, and their contributions to the university. In this application file, candidates are required to specify one of their publications as their "Main Research Work".

ARTICLE 17 - If the candidate applies for the associate professor position in a department other than the department and/or relevant division, the written opinion of the head of the department to which he/she applies is requested.

ARTICLE 18 - To determine the status and scientific or artistic qualifications of the candidates applying for the professorship, the NEU Executive Board selects five professors, the majority of whom are professors from other universities, from the field of science or art related to the announced position. These professors examine the documents in the file submitted by the candidates and write a separate report for each candidate, and if there is more than one candidate applying to be appointed to the position, they state their preferences. In these reports, the scientific or artistic qualifications and works of the candidates are evaluated, and their managerial, constructive, and developmental qualities and their efforts in training scientists and artists are stated in detail. Promotion and appointment of the applicant associate professor to the professorship is concluded by NEU Executive Board by considering these reports and delivering the file to the Rectorate for approval. The Professorship certificate of the candidate, whose appointment is made by the Rector, is issued by the NEU Rectorate.

## General Provisions

ARTICLE 19 - Promotion Criteria (Scoring Table) specified in Annex 1, and minimum requirements specified in Annex 2 of this Regulation are the criteria determined by the University Executive Board for promotion and appointment to academic positions. The University Executive Board uses these criteria as the decisive measure for the acceptance or rejection of appointment and promotion applications only. It is a must to conduct a detailed and analytical examination of the candidate's qualifications and performance while evaluating the applications. In the assessment carried out by the juries formed for promotion, or in the pre-appointment evaluation conducted by the Rectorate, the candidate's position and potential in the field of science, contribution to education and teaching, professional experience and contributions, his/her contributions that (s)he has provided or will provide to the objectives of the respective unit, contributions to university or academic unit management, and services in other universities are taken into consideration.

ARTICLE 20 - The Promotion and Appointment Criteria determined by the University Executive Board are the minimum criteria required for promotion and appointment to academic positions at the academic units affiliated with Near East University; to have met these criteria during the preliminary assessment process can't be regarded for the candidate as a vested right. The University Senate reserves the right to make changes in the criteria depending on the developments.

ARTICLE 21 - Candidates who apply for promotion to the positions of Assistant Professor, Associate Professor, and Professor, but are deemed unsuccessful by the scientific committee established after their applications are accepted, cannot reapply for the same position before a year elapses.

## Application

ARTICLE 22 - Candidates who meet the necessary conditions and have completed 5 years for the title of professor and 3 years for the title of associate professor can apply for promotion and appointment. Applications are evaluated by the "Promotion and Appointment to Academic Positions" Commission, which convenes three times a year.

Article 23 - If there are missing documents in the candidates' promotion and appointment application files, their applications are not taken into consideration.

Article 24 - The promotion and appointment application files of the candidates are submitted to the Rectorate in print-out and electronic format (CD/DVD/Flash Drive).

## The files comprise the following documents:

- Application letter addressed to the Rectorate,
- Curriculum vitae,
- A copy of the form in Annex 3 filled and completed with the necessary scoring,
- Documents proving that the candidate's articles are indexed in WOS, SCOPUS, FIELD INDEXES, and ULAKBIM,
- A copy of the doctoral diploma,
- Assistant professorship and/or associate professorship certificates,
- A copy of each of their works,
- Official acceptance letters or DOI numbers for accepted but not yet published publications as of the application date,
- Foreign language certificates (approved by the Education Unit),
- Trainer Training Certificate (for Assistant Professorship applications),
- CPS certificate,
- If the publication is a book, a printing contract,
- Documents proving citations and peer reviews must be attached. The applicant must have published at least $70 \%$ of his articles within the scope of the mandatory condition of the applied title,
- Declaration stating that there are no missing documents in the application file.


## Enforcement

ARTICLE 25 - This Regulation is in effect as of January 1, 2020.
